PREFACE

Modern Architects for Rural India (MARI) was started by a team of young professionals with social work background having a desire for heralding change towards egalitarian society. The founding members of the organization come from rural and tribal areas; who have undergone various hardships to complete higher education in social work.

They made a conscious choice of investing their professional knowledge, skills and experience for improving quality of lives in rural areas, in particular marginalised people, to achieve sustainable development. Immediately after establishing of MARI, R. Murali, Executive Director of MARI received one year fellowship (1989-90) from Gandhi Peace Centre (GPC).

The fellowship was used to select project area and identify needs and priorities of local communities. Parvathagiri mandal, a remote and backward mandal, in Warangal district was selected for initial intervention of the organisation. The GPC fellowship, thus, laid foundation for initiating organisational activities. Additionally, in-depth study was carried out on the experience of the NGO sector in dealing with development action; and gathered experts' inputs on developmental priorities. All the above helped MARI to better inform and equip on issues and concerns of the poor and marginalised sections, and find solutions thereof. The strategies, approaches and interventions of MARI were thus evolved based on infelt needs of people. In the process, it could influence people centric policies and programs.

During the course of more than 28 years journey, MARI has implemented a range of programmes to help people manage their own affairs sustainably, whilst simultaneously focusing on improving their living standards. MARI has also consciously made effort to link its work with other processes. Hence, macro-political and economic policies are closely observed, studied and assessed for understanding their impact on MARI's work and its target population. In the process, it could influence people centric policies and programs.

Soil Test:

350 grid-based soil samples were collected and soil health cards were provided to cotton farmers from 4 mandals



Highly Hazardous Pesticides campaign:

100 village level awareness campaigns were completed across 4 mandals covering 92 villages.



Vermicompost beds and Biochar units

The Better Cotton project as part of the sustainable practices promoted 20 vermicompost beds and 10 biochar units as part of the climate change intervention.



Workers Training on safe usage/ safe handling/ safe spraying techniques including importance of PPE

200 trainings were completed covering farmers and farm workers on proper use of spraying techniques and the importance of minimal Personal Protection Equipment (PPE) kits to ensure safety of human health.change intervention.

ANM/Anganwadi/Pregnant women/Lactating mother on negative impact of pesticides

40 meetings were conducted in 4 mandals covering pregnant ladies, lactating mothers including Anganwadi teachers and primary health care center to educate on importance of hygiene and avoid ill effects of pesticide cans and sprays



Village level awareness program promoting BCI principles and criteria through wall writings and paintings

102 Wall writings and 32 wall paintings were completed covering 38 villages in 4 mandals



900 farmers were surveyed to check on how many times do farmers use pesticides spraying during the crop cycle



10000 farmers were surveyed to understand what parameters do they check when buying seeds and their knowledge on selecting seed variety. The survey covered how many seed varieties each farmer uses on each farm land.

ACTIVITIES



1967 LG meetings were conducted on topics related to the practices of farmers in relation to the BCI principles and criteria.



226 training programs & 242 rallies conducted to women and farmers on Decent work to cater for addressing issues related to gender, child protection, safety of labourers, fibre quality, biodiversity, etc.



Conducted 37 meetings with school children and teacher, sensitizing them on child labour issues.



Conducted 90 Meetings with ANM, Anganwadi teacher, pregnant women, Lactating mother etc., on negative impact of pesticides, etc.

Warangal Gold City Compost:



Prajwal Farmers Producer Company Limited collaborated with Greater Warangal Municipal Corporation and District Collector of Warangal District for taking up the initiative of city compost from Rampur dumping yard. This year nearly 368600 quintal of compost was received and the same was sold to about 900 farmers.



No of saplings distributed to farmers/GP: 33522 (mango, teak, drumstick, marri, kanuga, guava, bamboo & coconut) and 26038 have survived.

Kheyti Organization:

Shade net farming is a special kind of arrangement in which the crop field is completely covered by transparent polyethene sheets. The nutrients are dissolved in water and supplied to plants through drip irrigation. Shade net farming is designed to increase crop production to almost 10-12 times. 300 farmers registered to avail this benefit and 290 installations are already done. Farmers invest Rs.30.3 lakhs and Kheyti contributes about Rs.2.7 Crores.

Livelihoods trainings:

Prajwal FPCL collaborated with National Academy Construction and JSS to undertake training programs to women, men and youth for their additional income sustainability. A total of 170 people have been identified from these villages to participate in this 90-day program. Co-operatives have taken the responsibility of providing expert trainers and are committed to supply sewing machines to all participants along with official certificates on completion of training.

Out of 161 women, 106 women received sewing machines free of cost worth of Rs. 8,48,000 (106 machines X 8,000/-) and 131 members received mason kits worth of Rs. 3,27,500/-.

IMPACTFUL CASE STORIES

CASE STUDY – 1

Mr. Udyala Tirupathi reddy from Pathipaka has started his participation in BCI project implementation since 2009 and today he is farmer who claims that the BCI project has enabled him to become a fully knowledgeable farmer to nil knowledge farmers.

KEY ACHIEVEMENTS

HORTICULTURE PLANTATION



Vegetative Cover Increase:

The implementation of project led to the plantation of over 30,000 horticultural plants across farms, significantly enhancing green cover in the region.



Farmer Income Diversification:

Approximately 200 farmers diversified their activities (income sources) by adopting a mix of 10 different horticultural species, resulting in an estimated 20–30% increase in income.



Skill Development:

Over 150 farmers received technical training and ongoing in-field support, enhancing their capacity to implement sustainable practices effectively.



Water Usage Efficiency:

The adoption of crop combinations reduced water wastage by approximately 15-20%, significantly improving the efficiency of water usage in these farms.



Common Land Plantation:

Through the Haritha Haram Program, 15 hectares of village common lands were covered with 12,000 tree saplings, actively involving the local community.




Challenges:

Prolonged heatwaves led to a 10–15% mortality rate in some plant species and market access issues continue to require further intervention.

KEY ACHIEVEMENTS

PLANTATION ON FIELD BUNDS



Increased Biodiversity:

The project resulted in the plantation of 5,000 trees on field bunds, which has led to a noticeable increase in biodiversity, with an observed 30% rise in bird and insect species.



Soil Quality Improvement: These plantations contributed to reducing soil erosion by up to 25% and improved soil fertility by 15-20% as reported by participating farmers.

Village Common Lands (Palle Prakruthi Vanam and Bruhat Prakruthi Vanam)



Community Engagement: 10 villages participated in tree plantation drives, resulting in the transformation of over 10 hectares of common lands.



Sustainability Focus:

Plans are in place for continuous monitoring and follow-up to ensure the long-term sustainability of these efforts, including protection from grazing and environmental hazards.

CASE STORY

KONDA ASHOK, MUTHIREDDY GUDEM VILLAGE:

Konda Ashok, a farmer from Muthireddy Gudem Village, faced challenges in maintaining his livelihood due to the infertile nature of his rainfed land. Initially focused on cotton, he struggled with low returns and increasing debt. Upon learning about the agroforestry project initiated by MARI with CSR support from Rabo Bank, Ashok decided to transition to mango cultivation, planting 150 mango saplings on 1.5 acres of his land.

and training from MARI, Ashok also began cultivating vegetables like Within three months, Ashok ₹10,000 invested land cultivation, yielding a total income of ₹30,000 from vegetable sales, additional ₹10,000 expected. Despite the water table and temperature of 20 saplings, Ashok remains optimistic. His mango plants are growing well, and he expects them to start yielding fruit in 2024, source. NATIONAL BANK FOR AGRICULTURE AND RURAL DEVELOPMENT



MARI has implemented 12 watershed development projects between 2001 to 2015 as part of which the watershed committees have received livelihood fund. MARI has suggested to NABARD that this should be the revolving fund at the village level and used sustainably to promote livelihood interventions in the villages to address the financial recovery of the farmers with on farm, off farm and non farm activities.



As on these watershed committees have a total revolving fund of Rs.21375218, by 1st April 2023 there was an outstanding of Rs. 15567570, during the year 258 farmers were given the total loan of amount of Rs.6293000/- and Rs. 6628431/- were recovered as repayments during the year. The total interest generated during the year through this exercise is Rs.1246895/- and out of which Rs.623448/- used for payment of salaries to the staff who have been facilitating this intervention. MARI can boast as one of the very few organizations which have sustainably using this facility with the support from NABARD.



Climate Proofing Project-Mekalagttu In Jangaon District



As part of the climate Proofing project, We completed below works end of the March 2024 programs related to under Integrated Farming Systems, Pandal Vegetable Cultivation, tank silt application, Deep ploughing FP Check wall and SP works are completed. NABARD RO officials came and visited for the plan of the Fourth phase action plan of the project and the Third phase completion of works in this project.

Promotion of Farmers Producers Companies (FPOs)



NATIONAL BANK FOR AGRICULTURE AND RURAL DEVELOPMENT

OBJECTIVES

To motivate the farmers to join as shareholders and purchase all their agricultural requirements, such as seeds, fertilizers and pesticides: equipment such as tarpaulin sheets, sprayers, ploughs, etc.

To convert or federate them into Farmers Producer Companies and link them to companies and markets that supply inputs.



MARI has been espousing the cause of Farmers Producer organizations with the support of NABARD. 14 FPOs are functioning within the limits of all 12 Watershed Projects and also covering surrounding areas with Maize, Vegetables and Diary as commodities/products.

MAJOR ACTIVITIES CONDUCTED:

Promotion of pandal Vegetable cultivation	Covered 5 FPOs with membership drive programs. Over 220 members have participated in these awareness programs, wherein the importance of FPC, roles and responsibilities of the members / shareholders ; benefits that may accrue to the members were elaborated.
Obtaining licenses	8 FPOs have received licenses from the Government agriculture departments to deal in transactions relating to seeds, fertilizers and pesticides.
Legal compliances	MARI has identified a Chartered Accountant and Company Secretary, who has been ensuring that the FPOs meet all the legal compliances under different laws such as companies act, GST act, Income tax act, etc. All the 14 FPOs are continuing to be legally functional institutions.
Input supply	8 FPOs are carrying on the Input supply business like fertilizers, quality seeds which are provided to the farmers through the input shop from each of the Farmer Producer companies. The total turnover was about Rs. 3Crores & profit Rs.2.5Lakhs, covering 4,500 farmer.
Custom hiring centre	4 FPOs received TRICOR grant. They have purchased Paddy Harvesters, in these 4 areas coverering 1200 farmers. They got income Rs. 6lakhs.







CASE STORY

MOHAMMAD ALAM, WELDING MACHINE UNIT

Mr. Mohammad Alam is a 39-year-old man who belongs to a family of migrants of Rohingya origin. His family has been living in camp 18 since 2016. Mr. Alam has a limited education, making him semi-illiterate. He has a loving family, consisting of his wife and their four children; two daughters and two sons. Three of their children attend school, while the youngest is just four years old. Mr. Alam works as a daily wage labourer, offering welding services to building owners within Hyderabad's Royal Colony of Balapur area.

Unfortunately, since Mr. Alam and his family migrated from Myanmar, they do not have access to social entitlements such as an Aadhar Card, Ration Card, voter ID card, bank account. As a result, they have no choice but to rent homes within the settlement.

STATUS OF PRESENT ENTERPRISE

Currently, Mr. Mohammad Alam works with welding machines granted to him by CRS-MARI. His efficiency and skills have enabled him to earn an average of Rs.18,000/- per month, working eight hours a day (depending on the work order received). He typically works 10-15 days per month. Previously, he used to rent welding machines daily, but with the new machine, he no longer has to do so, and can save up to Rs 400/- per day on working days.

Despite his decent income, Mohammad Alam cannot afford to save any amount as he supports his big family. As their children grow older, the family is finding it increasingly difficult to meet life's growing costs and demands. Nonetheless, since Muhammad Alam has been able to advance from depending on rented machinery to having his own and earning more, he is now content with his work and grateful to CRS-MARI for supporting him.



Enhancing Access to Sustainable Educational **Facilities** for Marginalized and Vulnerable Children in Telangana

Enhanced Quality of Teaching:

Appointment of five additional qualified teachers, improving the student teacher ratio to 1:30, which significantly enhanced individualized attention and led to better academic performance, particularly in English, science, and general intelligence.

Improved Safety and Learning Environment:



A full-time gardener maintained a clean, safe, and green school environment, promoting environmental awareness among students. Infrastructure improvements, such as new blackboards, tables, chairs, and energy-efficient ceiling fans, created a more conducive classroom atmosphere.



Enhanced Accessibility and Transportation:

The sustained operation of a school bus service ensured that children from 15 surrounding villages could safely and reliably attend school, improving attendance and alleviating parental concerns about their children's safety.



Nutrition and Well-being:

Provision of supplementary nutritious food, including seasonal fruits and snacks (addressing nutritional deficiencies), improving children's health, energy levels, and classroom engagement.



Capacity Building for Teachers:

Regular training sessions conducted by educational experts provided teachers with innovative teaching methods, enhancing their instructional capabilities and leading to improved learning outcomes for students.

WAY FORWARD

Building on these achievements, the project will continue to focus on sustaining and expanding the quality of educational services. A Multi-pronged planned approach/activities include further infrastructure improvements, continued support for teaching and non-teaching staff, and ongoing provision of nutritional support and transportation services, ensuring that every child has access to a safe, supportive, and resource-rich educational environment.

CASE STORY

CASE STUDY 1: CHILD GOOD HEALTH & HYGIENE PRACTICES

One of the children, Master V. identified with urinary tract infection was taken to SPARK hospital at Pirzadiguda where he was treated free of cost under the 'Arogya Sree scheme of the Telangana Govt. Initial treatment started in November and he was tested for infection and it came every month and doctor suggested to go for a surgery could become healthy withstand the surgery. Parents were informed and prepared to spend approximately 25,000 during the surgery towards all kinds of medication.

The operation was carried out after the government approved the 'Arogyasree' amount. While the operation was being done, the coordinator was in the hospital and completed the operation. Later the staff also visited. In the end he became normal and is coming to the centre regularly.

CASE STUDY 2: FROM RAHUL GANDHI NAGAR EVENING TUITION CENTER

We came to know that TSWRES (Telangana state welfare Residential Education Society) 202425 academic admissions join in 4th class and willing to go to hostel. Two children came forward to join at TSWRES they are 1.Moses S/o Philippu -eldest son of Elisha, them regularly attended tuition center. Coordinator took the initiative and motivated the two discussed with the principal Wesly Co-Education High school Principal. Principal agreed and given certificates to children. MARI online for Bona-fide and Date of Birth certificates for students. Tuition teacher motivated the paid special students and students and they both practiced practiced well and written exam without fear at Medchal examination center.

After one month results were announced. We are happy to inform you that Moses got 52 marks under General category and Lucky got 48 marks. Both students got seat in TSWRESGhatkesar, Hyderabad under general category and their parents are very much happy.

Protection and assistance to urban refugees at Telangana

PROJECT PERIOD

INTRODUCTION

MARI (Modern Architects for Rural India) has partnered with United Nations High Commissioner for Refugees in January 2024 to work with marginalised and vulnerable Refugee communities in the urban slums of Hyderabad and Ranga Reddy District. As part of the project, MARI intends to extend humanitarian support for the community through building access to basic needs such as Health, education and livelihood to the refugees in Hyderabad.

MAJOR OBJECTIVES OF THE PROJECT

Access to Territory, Registration and Documentation and facilitate RSD process:

Support UNHCR's registration and continuous registration activities for refugees and asylum seekers including biometrics enrolment and distribution of UNHCR issued documents, with monitoring and supervision by UNHCR in line with UNHCR registration standards and applicable SOPs.



Address Gender-based violence:

Ensure Refugee and asylum seekers have access to national multi-sectoral GBV response across locations and strengthen the access and integration of refugees and asylum seekers to such national services and response.



Child Protection:

Advocate for inclusion of refugee children into national child protection systems for better child protection outcomes. This includes working with range of state and civil society actors involved in the prevention, mitigation, and response to child protection risks. To support children, families, communities with effective multi sectoral prevention and response activities ensuring immediate access to appropriate services including cash-based interventions, access to; life skills training, recreational opportunities, MHPSS, livelihood activities to mitigate the child protection risks.



General Protection:

Address all protection concerns that effects the survival of the asylum seeker and Refugees. This includes constant awareness on law of land and stronger advocacy efforts. For detention cases coordinate with the FRRO/detention authorities for various activities.



Well - Being:

Comprehensive vulnerability assessment of refugees and asylum seekers will be carried out. Timely review and disbursement of cash assistance based (CBI) on UNHCR's guidance/criteria for regular, one time and emergency cash assistance.



Date Management:

To have a concrete, precise and updated date base for the regular operations of the project. To follow UNHCR SoP on data management.



Health:

To facilitate and strengthen the access of refugees and asylum seekers to government health facilities, including immunization, reproductive health services, maternal/child healthcare, and birth registration.

Education:



Enable children and youth to learn, thrive and develop holistically. To facilitate access of refugee children and youth for pre-primary, primary, secondary and tertiary education and collect and maintain enrolment data by age, gender, nationality to facilitate improved monitoring of progress.



Self-reliance, economic inclusion and livelihoods:

To implement the updated Livelihood Strategy 2024 that focuses on transferable skill development, job placement and provision of microgrants. Partnerships and Networking to be an integral part of Livelihood Program and new partnerships will be explored for skill development trainings and orders to the refugee artisans.



Resettlement:

Facilitate remote resettlement interviews. For detention cases that are in the resettlement pipeline, support in remote interviewing and logistical arrangements for the release of refugees from detention to complete for predeparture interviewing and logistical arrangements for the release of refugees from detention to complete for pre-departure formalities



Complementary Pathways:

To assist refugees and asylum seekers to access durable solutions in third countries through complementary pathways, which are safe and regulated avenues that complement resettlement. This includes various projects on labour mobility and educational pathways with the support of partners.



Core relief items, food, NFI, sanitary materials, seasonal support (subject to budgets available from UNHCR)

PROGRESS AND KEY ACHIEVEMENTS

From January to March 2024, several significant achievements were realized. The transition of the project from Save the Children India to MARI was successfully completed, ensuring a smooth shift in management.

A comprehensive baseline survey was conducted to assess the demographic structure. Coordination meetings with MARI projects were held to streamline efforts and enhance collaboration. MARI Project personnel hosted a UNHCR mission visit to review the Project Framework Agreement (PFA)

Registration and continuous registration services were provided to 613 community members.

An awareness meeting with the Community Action Group (CAG) of Rohingya leaders covered child protection, gender-based violence (GBV) training of trainers (ToT), and health awareness, reaching 166 members. Protection issues, including incidents of assault, were addressed effectively.



Health services, including immunization and referrals, supported 317 individuals.

MARI Project personnel consulted the Chief Health Officer (CHO) and the Medical Officer in Balapur to ensure the continuity of immunization services for Rohingya children and women.



PROGRESS AND KEY ACHIEVEMENTS

Two students were enrolled in IGNOU courses. Educational support was extended to 187 children at six Child Friendly Learning (CFL) centres, with 66 children receiving remedial classes.

MARI Project personnel were engaged with various key stakeholders to address and advance our objectives. MARI Project personnel met the District Education Officer (DEO), Deputy Director of School Education (DYSE), and the State Sarva Shiksha Abhiyan (SSA) representatives to facilitate the registration of children's data in the UDISE+ app of the Government of Telangana.

Additionally, nine special children were supported in partnership with LIGHT NGO for their cognitive and motor development.



A total of 43 GBV cases were resolved, including 11 new cases, with beneficiaries receiving referral and shelter services.

To address a protection issue, MARI contacted the Saroor Nagar Women Police Station and engaged with the CWC Ranga Reddy unit.



32 community members submitted applications for the Entrepreneur Development Program (EDP) and micro grants.

We coordinated with the NIRD RTP unit for the successful organization of the annual exhibition.

CONCLUSION

To conclude, it is stated the first quarter of 2024 has been marked by substantial progress and impactful engagements with both the community and stakeholders. The successful transition of the project from SCI to MARI has laid a strong foundation for continued growth and effectiveness. Our efforts in conducting a baseline survey and coordinating with MARI projects have enhanced our understanding and collaboration, ensuring more targeted and efficient interventions.

The active involvement of the UNHCR mission and our focused approach towards addressing protection issues have significantly strengthened our protective safeguarding measures. The awareness initiatives with the Community Action Group and the support provided to community members through registration, health services, and educational opportunities emphasized our commitment to holistic support and empowerment.

MARI is particularly encouraged by the positive outcomes in addressing GBV cases, supporting livelihood initiatives, and partnering with organizations like LIGHT NGO to aid special children. These achievements reflect our dedication to fostering a resilient and empowered community.

Looking ahead, MARI remains committed to building on these successes, deepening our engagement with stakeholders, and continuously improving our services to meet the evolving needs of the communities we serve.

Specifically, the initiative targets **10,027 families** residing in **28 different slums** in Kushaiguda and Alwal areas, Hyderabad

These communities, located around Hyderabad, Telangana, face numerous challenges including lack of basic documents, inadequate access to entitlements for eligible people, and substandard housing, water, sanitation, drainage, road facilities etc.

The MARI's project is designed with clear objectives to transform these communities through a series of strategic actions. We also have an add on support project in Balapur where we established and running 3 CFLS centres with 153 pre-school children focusing on pre-school education with supplementary nutritious food for children, WASH work in the community with- toilet repairs, storm water structures, new and repair of borewells and support refugee community for emergency medical needs and referral services for women for institutional delivery.

ISSUES ADDRESSED

- The overarching goal of community empowerment is enabling access to basic documents and facilitating entitlements.
- This allows families in the slums to secure admissions for their children in reputed government educational institutions such as Navodaya, KGBV, Model, and Residential schools. This access to quality education is transformative, offering these children a pathway out of poverty and toward a brighter future through education. The approach aims to improve living conditionsof the targeted communities.
- Also, an ambitious yet vital part of the implementation strategy is the development of six slums as model entities with significantly enhanced basic amenities. Improvements in water supply, sanitation facilities, drainage systems, and waste management services are planned.
- This model slum approach aims to not only improve living conditions within these communities but also serve as a replicable framework for other slums.

As per MARI's Baseline survey, done in June 2024, we found that most of the population doesn't have basic documents and schemes.

CONVERGENCE

- MARI is keen in working in close collaboration with all government line departments in the process. Also wants to strengthen the solidarity between key stakeholders and like-minded organizations to ensure the sustainability and expansion of these vital services.
- Till now team visited all concerned government departments and familiarized with them-both state level and district level offices -HMWSSB, MCH, Health, Education, Civil Supplies, RWS, Electricity, Pension, LIC, WCD, etc.

ACHIEVEMENTS OF BASTI VIKAS PROJECT TILL NOW:

- Baseline is done for all 10,027 families (100% coverage) and data sheets are ready with BMs – slum, family and individual wise
- Online MIS for all project activities has been developed and everyday monitoring is in progress
- Identified, trained and strengthened Basti Vikas Manch (BVM) which are community- based organizations in 28 slums where the project is implemented.
- BVMs are crucial in the entire project period and to take forward the project objectives on a long run.
- Developed a Compendium of 17 documents and 24 schemes, printed, and circulated among staff
- From July to August in two months our team could facilitate accessing 2830 various documents and 279 different schemes to the communities in 28 slums.
- Also 102 drop out children got re-joined in govt. schools, and 18 applications for Navodaya entrance and 4 applications for pre matric scholarship has been submitted
- 28 slum profiles have been developed, FGDs conducted in 9 slums for developing micro plans for model slums



Wellbeing Out of Waste (WOW)



Wellbeing Out of Waste (WOW) is a CSR initiative of ITC started in 2007 and Modern Architects for Rural India (MARI) is the implementing NGO in Hyderabad since 2015

PROJECT OUTREACH

Geographies and beneficiaries outreached:

During the year, the project has covered around 335 schools within the limits of Greater Hyderabad Municipal Corporation and the municipalities of Khammam and Medak.

OBJECTIVES

Educating people on recycling of the waste to protect environment, conserve natural resources, and inculcate the habit of source segregation of waste amongst the citizens. Maximizing recovery of the dry recyclable waste and progressively eliminate recyclable waste reaching the landfill is also an important objective of our WOW initiative.

ACTIVITIES

Collected 1220.27 MTs of dry waste from the schools.

Covered **8 municipalities** through student volunteers and volunteers in Peerzadiguda, Kalwakurthy, Gadwal, Badangpet, Bhongir, Dundigal, Ghatkesar, Jalpally and Medchal municipalities and created awareness to **146594** households in these municipalities.

Established **Dry Recyclable Collection Centre (DRCC)** in Peerzadiguda Municipal Corporation.

On the occasion of **World Environment Day**, the WoW Project, Hyderabad in collaboration with Nizampet Municipal Corporation and BVRIT college have jointly organized a rally at Nizampet Lake. A total of **80 members** had participated in the rally followed by the clean-up drive at the lake.

On the occasion of 77th Independence Day Celebration,

ITC & MARI team had participated in celebrations at various schools and Municipal Corporations in Telangana.

INDIAN SWACHHATA LEAGUE 2.0 was organized by Nizampet Municipal Corporation on 17th September 2023. WOW Hyderabad team had participated in this event.

WOW Hyderabad in collaboration with municipal offices had jointly organized and participated in Swachhatha Hi Seva events on account of Gandhi Jayanthi on 1st October 2023 at 5 locations with participation of around **350 members** in lake cleanup drive, **150 NSS Volunteers** in Nampally Railway station and **over 1000 residents** in waste pick drive and rally. 
Upgradation and beautification of three $\mbox{DRCC's}$ (Medak, Peerzadiguda & Manikonda) had been completed.

WAY FORWARD

- To organize more ISRCs to create awareness to school children on solid waste management.
- To expand program to municipalities in Telangana State and to build capacities of Resource Persons on solid waste management and source segregation.

The project supported municipalities, reached 1.49 lakhs households and created awareness on segregation of waste at source; Also reached 1.5 lakh students of 330 schools through recycling championship. Through this intervention, provided human resource support to two Dry Waste Collection Centres in Gadwal and Medak municipalities and ensured that the waste is segregated at households, transported it to the DRCCs. It the municipalities made in reduction of recyclable waste is going to landfill and enhanced income to the waste handlers.

The project's primary objective was to enhance the engagement of citizens and civil society organizations (CSOs) in implementing and monitoring sanitation services under the City-Wide Inclusive Sanitation (CWIS) framework. This aimed to promote inclusive, equitable, and sustainable sanitation solutions across five key urban areas in Telangana.

MAPPING AND PROFILING OF CSOS

Conducted a comprehensive mapping exercise to identify and profile existing Civil Society Organizations (CSOs) across the project locations.

Developed a compendium of 194 profiles of CSOs in Warangal and produced profile booklets for Siddipet (62), Sirsilla (71), Nalgonda (62), and Peerzadiguda (60).

FORMATION OF COLLECTIVE PLATFORMS

Established the "Swach Warangal Poura Sanghala Vedika (SWPSV)" in Warangal, a collective platform for CSOs to engage in city sanitation development.

Organized consultations and workshops to develop the vision, objectives, and terms of reference (TOR) for SWPSV



MONITORING & CITIZEN REPORTING

Designed four online monitoring tools for assessing sanitation services, including public toilets, de-sludging of septic tanks, door-to-door waste collection, and elimination of open defecation.

Conducted training for SWPSV members and National Service Scheme (NSS) volunteers on the use of these tools.

Executed a comprehensive monitoring exercise across 26 wards in Warangal, producing citizen report cards that were presented to the Greater Warangal Municipal Corporation (GWMC).

CAPACITY BUILDING & DISSEMINATION

Developed learning products, including a draft booklet on the role of CSOs in city sanitation and a process documentation presentation, to be shared at state and national levels.

Engaged with local Urban Local Bodies (ULBs) in the project towns to facilitate the adoption of similar citizen engagement frameworks.

Enhanced Citizen Engagement: The project successfully mobilized CSOs and citizens to actively participate in sanitation service monitoring and advocacy, leading to sustainable collective platforms like SWPSV.

 Capacity Building: The project built the capacity of CSOs and local stakeholders, equipping them with the necessary tools and knowledge to continue contributing to sanitation improvements in their communities.

MARI's Support in Developing Sanitation Improvement Plans for Ranchi and Dhanbad cities of Jharkhand



OVERVIEW

During the financial year **2023–2024**, MARI in collaboration with **GWSC-AIT**, played a crucial role in supporting the **Jharkhand State Government**, specifically focusing on sanitation improvements in **Ranchi & Dhanbad** cities. This involved developing strategic plans, engaging communities, and addressing gender and equity issues, particularly in the context of the proposed city sewerage projects.

KEY CONTRIBUTIONS

Community Engagement and Social Awareness



Stakeholder Involvement:

MARI facilitated the involvement of various stakeholders, including Residents' Welfare Associations, Women SHGs, slum-level organizations, and NGOs, ensuring that the project design was inclusive and responsive to the diverse needs of low-income communities.

Public Cooperation:

Strategies for IEC were suggested to educate the public on responsible sanitation practices, leading to greater community buy-in and cooperation for the proposed sanitation improvement projects.

Gender Equity and Vulnerable Groups



Vomen's Leadership

MARI suggested specific activities to ensure that women's perspectives were included in the project planning, providing them with opportunities for leadership and engagement. Capacity-building initiatives were suggested to empower women to participate actively in sanitation-related micro-enterprises, such as hygiene product marketing and de-sludging services.

upport for Vulnerable Groups:

Suggested practical approaches for the project design to include targeted strategies to ensure accessibility and affordability of sanitation services for the urban poor, with special attention to slum areas and hard-to-reach communities. This approach aimed to bridge the gap between service provision and the needs of marginalized populations.

Sanitation Infrastructure and Service Delivery

Toilet Infrastructure:

MARI contributed to assessing and planning public, community, and modular toilets across the two cities of Ranchi and Dhanbad. The focus was on improving accessibility, particularly for women, children, and people with disabilities. The project also sought to enhance the maintenance and management of these facilities through partnerships with SHGs and local NGOs.



Desludging Operations:

MARI's field visits identified the current practices and challenges in septic tank de-sludging, leading to recommendations for improving sanitation workers' operational efficiency and safety. The input from MARI also emphasized the need for capacity building among de-sludging operators to enhance service delivery and compliance with environmental standards.



Risk Mitigation:

MARI developed strategies to mitigate potential environmental hazards related to sludge management, including regulating de-sludging practices and promoting safe disposal methods. It also recommended provisions for the occupational safety of sanitation workers, emphasizing the importance of protective equipment and training.

IMPACT

MARI's engagement in Ranchi and Dhanbad cities has laid a foundation for sustainable sanitation management by integrating community engagement, gender equity, and environmental safety into the project design. The strategic plans and recommendations provided by MARI are intended / expected to guide the successful implementation of the proposed sewerage projects, contributing to improved public health, environmental protection, and social equity in Jharkhand.

During the meeting, the team has decided to expand its network among four more state chapters in the country i.e. Himachal Pradesh, Rajasthan and Northeastern India.
- 3. Evidence Based Advocacy MARI through its collective CSO network conducted a study to understand the process of utilization of the 15th Finance Commission Grants by Panchayati Raj Institutions (PRIs) and Rural Local Bodies (RLBs).
- A National virtual consultation was organized to solicit feedback, in which sector experts from across India and S.A. on the study conducted by MARI through its CSOs network.

Conducted Short workshop with Parents / Community Members from 9 project schools and highlighted the need for their involvement in providing better sanitation facilities to their children in the schools. A total of 374 Parents / Community Members have participated in these workshops (111 males and 263 females).

Conducted WASH club meetings in all 11 project schools. Badges were distributed to WASH club members in all the project schools covering a total of 240 students and enthused them to promote better hygiene practices among their school children.

Distributed 115 Menstrupedia (Girls) and Gullu (Boys) Books as part of IEC material distribution in 10 schools to promote knowledge on safe MHM practices.

Completed installation of Sanitary Napkin Incinerators in three project schools benefitting 604 girl students.

KEY HIGHLIGHTS OF THE INTERVENTION DURING THE REPORTING PERIOD

OBJECTIVE 1

 The SWA Regional Coordinator hosted by MARI FANSA engaged with government of India to have them as one of the mentor countries for the Head of State Initiative (HoSI). SWA is currently engaging in this initiative and India has in principle agreed to be a mentor country. The project contributed in getting out a Presidential declarationand Head of State Initiative frorm some Government Heads.



OBJECTIVE 2

• The project initiated a focused engagement with government in providing technical support for strengthening the multi stakeholder processes. The project is sharing examples from India as part of the peer learning.



OBJECTIVE 3

- The project worked with select countries, to identify specific issues on WASH financing with a particular focus on climate financing.
- Sector efficiency gaps were identified with the government and other stakeholders. SWA will be releasing small technical assistance grant to address some identified bottlenecks.



WAY FORWARD

The project will continue working with India and select priority countries for specific objectives. More focus will be given to the Head of State Engagement.



ROLE OF MARI FANSA

MARI FANSA, being the voice of civil society organizations (CSOs) in S.A. has actively played a crucial role in engaging with the SWA Global platform since its inception. By mobilizing CSO constituency input and advocating for systematic progress tracking, FANSA has worked closely with SWA to ensure the accountability of governments and promote inclusive WASH initiatives. MARI FANSA's extensive network and partnerships with various key sector partners in the region equip it to play a significant role in strengthening the SWA multi-stakeholder and Mutual Accountability Mechanism (MAM) processes.

MARI FANSA also led on matters related to the pastoral care of the SWA Regional Coordinator, including wellbeing, working hours, sick leave and holidays





Other Projects

MARI has been actively collaborating with Hyderabad Metropolitan Water Supply and Sewerage Board in improving people's participation in conservation of water supplied by the board and also increase ground water levels in Hyderabad city. In previous years MARI had facilitated construction of rainwater harvesting pits individual households, apartments, major government and non-government institutions. HMWSS&B also supported MARI in construction of 205 rain water harvesting pits during 2018-20 in public places. Similarly, HMWSS&B also supported other local NGOs.

During this financial year HMWSS&B has requested MARI to take up renovation of existing rainwater harvesting pits in Uppal area in Division 14. Hence, MARI facilitated repairs to 78 rainwater harvesting pits and submitted the report to them on the work done.

The participants were informed about their roles in water conservation, maintenance of rainwater harvesting pits, importance of water in our daily life, our practices leading to wastage water, etc.

MARI has completed the implementation of this project in 3 schools in Jangaon district and handed over the sanitation infrastructure to the school authorities and requested them to ensure proper use and maintenance of the same so that children's right to education can be realized.
